PROCUREMENT OF STEEL OPEN SHELVES

1. The Government Service Insurance System (GSIS), through the GSIS Corporate Operating Budget for CY 2015, intends to apply the total amount of **THREE MILLION FIVE HUNDRED EIGHTY THREE THOUSAND FIVE HUNDRED PESOS (Php3,583,500.00)** being the total Approved Budget for the Contract (ABC) to payment for the **Procurement of Steel Open Shelves** for various GSIS Central and Branch Offices:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *GSIS* now invites bids for the **Procurement of Steel Open Shelves** for various *GSIS* Central and Branch Offices. Delivery of the Goods is required *within forty-five (45) calendar days for Central and Luzon Branch Offices and seventy-five (75) calendar days for Visayas and Mindanao Branch Offices from the receipt of the Notice to Proceed*. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

4. Interested bidders may obtain further information from the *GSIS* Bids and Awards Committee (GBAC) Secretariat and inspect the Bidding Documents at the address given below from **Monday to Friday 8:00 AM to 5:00 PM** excluding holidays.

A complete set of Bidding Documents may be purchased by interested Bidders starting on **06 April 2015** from the given address and upon payment of a nonrefundable fee for the Bidding Documents amounting to **PhP5,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

5. The *GSIS* will hold a Pre-Bid Conference on **14 April 2015, 10:30AM** at the GBAC Conference Room, Level 2, Core G, *GSIS* Building, Financial Center, Pasay City. The Pre-Bid Conference shall be open to all interested parties.
6. Bids must be delivered to the GBAC Secretariat, Level 2, Core G, *GSIS* Building, Financial Center, Pasay City on or before **28 April 2015, 10:30AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids shall not be accepted.

Bid opening shall be conducted on **28 April 2015, 11:00 AM** at the GBAC Conference Room, Level 2, Core G, *GSIS* Building, Financial Center, Pasay City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the given address.

7. The GSIS reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
