INVITATION TO BID

Supply and Delivery of Tokens for Service Awardees (Commemorative Gold Necklace with Pendant)

1. The Government Service Insurance System (GSIS) through the GSIS Corporate Operating Budget for CY 2015, intends to apply the sum of **NINE HUNDRED TWENTY SEVEN THOUSAND PESOS (Php927,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply and Delivery of Tokens for Service Awardees (Commemorative Gold Necklace with Pendant)**.

2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. The GSIS now invites bids for the **Supply and Delivery of Tokens for Service Awardees (Commemorative Gold Necklace with Pendant)**. Delivery of the Goods should be completed within fifteen (15) calendar days upon approval of the prototype by the 78th GSIS Anniversary Steering Committee. Bidders should have completed, within the past five (5) years from the date of submission and receipt of bids, a contract similar to the Project whose amount is at least 25% of the ABC. Similar contract refers to **Supply and Delivery of Gold Necklace with Pendant**. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instructions to Bidders (ITB).

The bidders should have been in the gold jewelry business for at least ten (10) years.

4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

- Interested bidders may obtain further information from the GSIS Bids and Awards Committee (GBAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00AM to 5:00PM, Monday to Friday excluding holidays.

- The GSIS Bids and Awards Committee will hold a Pre-Bid Conference **17 April 2015, 10:00 AM** at the GBAC Conference Room, Level 2 Core G, GSIS Central Office, Financial Center Pasay City. The Pre-Bid Conference shall be open to all interested parties.
- Bids must be delivered to the address below on or before **30 April 2015, 10:00 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids shall not be accepted.

Bid opening shall be on **30 April 2015, 11:00 AM**, at the GBAC Conference Room, Level 2 Core G, GSIS Central Office, Financial Center Pasay City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the given address.
