**INVITATION TO BID
FOR THE**

**SUPPLY, DELIVERY AND ASSEMBLY OF GYM EQUIPMENT
FOR THE GSIS CENTRAL OFFICE AND BRANCH OFFICES-
REBIDDING**

1. The Government Service Insurance System (GSIS), through the GSIS Corporate Operating Budget for CY 2015, intends to apply the total amount of **ONE MILLION THREE HUNDRED NINE THOUSAND PESOS (PhP1,309,000.00)** being the total Approved Budget for the Contract (ABC) to payment for the contract for the *Supply, Delivery and Assembly of Gym Equipment for the GSIS Central Office and Branch Offices*.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The GSIS now invites bids for the *Supply, Delivery and Assembly of Gym Equipment for the GSIS Central and Branch Offices*. Delivery and Assembly of the Goods is required *within thirty (30) calendar days for the GSIS Central Office and sixty (60) calendar day for the GSIS Branch Offices*. Bidders should have completed, within *five (5) years* from the date of submission and receipt of bids, a contract similar to the Project whose amount is at least 50% of the ABC. Similar Contract refers to the supply, delivery and assembly of gym equipment. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

4. Interested bidders may obtain further information from the GSIS Bids and Awards Committee (GBAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00AM to 5:00PM, Monday to Friday excluding holidays.

A complete set of Bidding Documents may be purchased by interested Bidders starting on **21 July 2015** from the address below and upon payment of a nonrefundable fee for the Bidding Documents amounting to **Php5,000.00.**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

5. The GSIS Bids and Awards Committee will hold a Pre-Bid Conference on **29 July 2015, 1:30pm**, at the GBAC Conference Room, Level 2, Core G, GSIS Central Office, Financial Center, Pasay City, which shall be open to all interested parties.
6. Bids must be delivered to the address below on or before **12 August 2015, 1:00pm**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids shall not be accepted.

Bid opening shall be on **12 August 2015, 1:30pm** at the GBAC Conference Room, Level 2 Core G, GSIS Central Office, Financial Center, Pasay City. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the given address.

7. The GSIS reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
