INVITATION TO BID

**SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF
VARIOUS AIRCONDITIONING EQUIPMENT**

1. The Government Service Insurance System (GSIS) through the GSIS Corporate Operating Budget for CY 2016 intends to apply the sum of **Twenty Five Million Pesos (Php 25,000,000.00)** being the Approved Budget for the Contract (ABC) to payments for the contract for the **Supply, Delivery, Installation and Commissioning of Various Airconditioning Equipment** with the following breakdown by Lot:

Lot No.	ABC
LOT 1 – Luzon	Php 12,100,000.00
LOT 2 – Visayas	Php 5,000,000.00
LOT 3 – Mindanao	Php 7,900,000.00

Bids received in excess of the ABC per Lot shall be automatically rejected at bid opening.

2. The GSIS now invites bids for the **Supply, Delivery, Installation and Commissioning of Various Airconditioning Equipment**. Delivery of the Goods should be completed within Two Hundred Ten (210) calendar days after receipt of the Notice to Proceed. Bidders should have completed, within the past five (5) years prior to the deadline for the submission and receipt of bids, a contract similar to the Project whose amount is at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is open only to all interested local bidders.

4. Interested bidders may obtain further information from the GSIS Bids and Awards Committee (GBAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00AM to 5:00PM, Monday to Friday excluding holidays.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

5. The GSIS Bids and Awards Committee will hold a Pre-Bid Conference on **10 January 2017, 10:30AM** at the GBAC Conference Room, Level 2 Core G, GSIS Building, Financial Center Pasay City and *simultaneously at the GSIS Cebu Branch Office, Leon Kilat Street, Barangay Kalubihan, Cebu City and GSIS Davao Branch Office, McArthur Highway, Matina, Davao City, via video conference*. The Pre-Bid Conference shall be open to all interested parties.
6. Bids must be delivered to the address below OR at the *Office of the Branch Manager GSIS Cebu Branch Office, Leon Kilat Street, Barangay Kalubihan, Cebu City* OR *Office of the Branch Manager, GSIS Davao Branch Office, McArthur Highway, Matina, Davao City* on or before **24 January 2017, 10:00AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids shall not be accepted.

Bid opening shall be on **24 January 2017, 10:30AM** at the GBAC Conference Room, Level 2 Core G, GSIS Building, Financial Center Pasay City and *simultaneously at the GSIS Cebu Branch Office, Leon Kilat Street, Barangay Kalubihan, Cebu City and GSIS Davao Branch Office, McArthur Highway, Matina, Davao City, via video conference*. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the given address.

After the Bid Opening, a detailed evaluation of the financial component of the eligible bid/s shall be conducted to determine the Lowest or Single Calculated Bid (LCB or SCB). Only the bidder with the LCB or SCB shall be notified within seven (7) calendar days to submit post-qualification documents.

7. The GSIS reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
