Section I. Invitation to Bid

SUPPLY, DELIVERY AND INSTALLATION OF BLINDS AT THE CONFERENCE HALL, DINING AREA AND PGM'S APARTMENT, LEVEL 8 GSIS CENTRAL OFFICE (LOT 1 – MOTORIZED AND MANUAL BLINDS) - REBIDDING

1. The Government Service Insurance System (GSIS) through the GSIS Corporate Operating Budget for CY 2016 intends to apply the sum of **Two Million Pesos (Php2,000,000.00)** being the Approved Budget for the Contract (ABC) for payment for the contract for the **Supply, Delivery and Installation of Blinds at the Conference Hall, Dining Area and PGM's Apartment, Level 8 GSIS Central Office (Lot 1 – Motorized and Manual Blinds)**.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The GSIS now invites bids for the Supply, Delivery and Installation of Blinds at the Conference Hall, Dining Area and PGM's Apartment, Level 8 GSIS Central Office (Lot 1- Motorized and Manual Blinds). Delivery of the Goods should be completed within sixty (60) calendar days from receipt of the Notice to Proceed. Bidders should have completed, within the past three (3) years prior to the deadline for the submission and receipt of bids, a contract similar to the Project whose amount is at least 50% of the ABC or at least two (2) similar contracts whose aggregate contract amounts should be equivalent to at least fifty percent (50%) of the ABC, with the largest of these similar contracts equivalent to at least twenty-five percent (25%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184 and in ITB Clause 5.2 of the Bid Data Sheet in the Bidding Documents.

- Interested bidders may obtain further information from the GSIS Bids and Awards Committee (GBAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00AM to 5:00PM, Monday to Friday excluding holidays.

A complete set of Bidding Documents may be acquired by interested Bidders starting on **31 March 2017, from 8:00AM to 3:00PM** and upon payment of a nonrefundable fee for the Bidding Documents amounting to **Php5,000.00**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

- The GSIS Bids and Awards Committee will hold a Pre-Bid Conference on **10 April 2017, 10:00AM** at the GBAC Conference Room, Level 2 Core G, GSIS Building, Financial Center Pasay City. The Pre-Bid Conference shall be open to all interested parties.
- Bids must be delivered to the address below on or before **24 April 2017, 9:30AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late bids shall not be accepted.

Bid opening shall be on **24 April 2017, 10:00AM** at the GBAC Conference Room, Level 2 Core G, GSIS Building, Financial Center Pasay City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the given address.

After the Bid Opening, a detailed evaluation of the financial component of the eligible bid/s shall be conducted to determine the Single or Lowest Calculated Bid (SCB or LCB). Only the bidder with the SCB or LCB shall be notified within seven (7) calendar days to submit post-qualification documents.

- The GSIS reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
