Purpose : **Provision of Cable TV to various offices of the GSIS Central Office**

I. SCOPE OF SERVICES:

1. Provision of twenty-five (25) outlets of Cable TV (CATV) Services for a period of thirty-five (35) Months from 01 February 2020 to 31 December 2022 on the following GSIS offices:
 - 1.1. Office of the President and General Manager – 1 outlet
 - 1.2. Office of the Chief of Staff – 1 outlet
 - 1.3. Office of the Chairman of the Board – 1 outlet
 - 1.4. Office of the Board of Trustees – 7 outlets
 - 1.5. Office of the Executive Vice Presidents – 3 outlets
 - 1.6. Office of the Senior Vice President – CSG – 1 outlet
 - 1.7. Office of the Vice President – CCO – 1 outlet
 - 1.8. Corporate Communication Office – 2 outlets
 - 1.9. Investment Trading – 1 outlet
 - 1.10. Security Department – 1 outlet
 - 1.11. Commission on Audit – 1 outlet
 - 1.12. Pensioner's Lounge – 1 outlet
 - 1.13. E-Card Releasing – 1 outlet
 - 1.14. Office of the Executive Vice President – 1 outlet (new)
 - 1.15. GSIS Main Lobby – 1 outlet (new)
 - 1.16. GSIS Drop-off Area – 1 outlet (new)
2. Supply and installation of Three (3) additional outlets (Digiboxes) at the GSIS Lobby and Drop-off Area

II. SUPPORT SERVICE REQUIREMENTS

1. The Service Provider shall have an on-site support for troubleshooting and repair cable network system. The response time shall be within twenty-four (24) hours and the restoration of the system shall within seventy-two (72) hours upon receipt of notification from the GSIS either by email or phone call.

III. SERVICE PROVIDER'S QUALIFICATION

1. The provision of CATV services network shall be undertaken by a cable service provider duly accredited by the National Telecommunications Commission (NTC), aware of the technical standards and existing regulations.
2. Must be in the CATV services provider business for at least five (5) years and must show proofs thereof.

3. Must provide Bloomberg Channels as well as maintain best cable channels and programs with at least 70 channels with 24-hour coverage.

IV. TERMS OF PAYMENT

1. Payment shall be made every three (3) months of completed services and upon submission of the required documents/reports.
2. When the SERVICE PROVIDER fails to satisfactorily perform the services within the specified schedule, inclusive of duly granted time extensions, if any, the SERVICE PROVIDER shall be liable for damages for the delay and shall pay the procuring entity liquidated damages, an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the delayed services scheduled, for every day of delay until such services are finally performed and accepted by the procuring entity concerned.
